### VA Publishes Final Regulation to Aid Veterans Exposed to Agent Orange in Korea

Washington – Veterans exposed to herbicides while serving along the demilitarized zone (DMZ) in Korea will have an easier path to access quality health care and benefits under a department of Veterans Affairs (VA) final regulation that will expand the dates when illnesses caused by herbicide exposure can be presumed to be related to Agent Orange.

"VA's primary mission is to be an advocate fro Veterans" said Secretary of Veterans Affairs Eric K. Shinseki "With this new regulation VA has cleared a path for more Veterans who served in the demilitarized zone in Korea to receive access to our quality health care and disability benefits for exposure to Agent Orange."

Under the final regulation published today in the *Federal Register*, VA will presume herbicide exposure for any Veteran who served between April 1, 1968, and Aug. 31, 1971, in a unit determined by VA and the Department of Defense (DoD) to have operated in an area in or near the Korean DMZ in which the herbicides were applied.

Previously, VA recognized that Agent Orange exposure could only be conceded to Veterans who served in certain units along the Korean DMZ between April 1968 and July 1969.

### VA Adds Ships to Agent Orange List

VA announced in September that it has expanded its list of ships that served in areas of Vietnam that now qualify for the disability compensation due to Agent Orange herbicide exposure.

Veterans who served on the ships between Jan. 9, 1962 and May 7, 1975, can file VA claims for 15 medical conditions VA presumes to have been caused by Agent Orange exposure. They can find the list of U.S. Navy and Coast Guard ships at

www.publichealth.va/exposures/agent orange.

Vets can also call VA's Special Issues Helpline at 1-800-749-8387 and press 3.

Veterans afflicted with the three conditions (Parkinson's disease, various chronic B-cell leukemias and ischemic heart disease) VA added to the Agent Orange presumptive list last year can file claims at

www.fasttrack.va.gov/AOFasttrack/.

According to VA's Sept. 2 announcement, "Service onboard ships anchored in an open-water harbor, such as DaNang Harbor, or on ships on other open waters around Vietnam during the war, is not considered sufficient for presumption of Agent Orange exposure."

## North Korea Agrees to MIA Talks

Discussion between North Korea and the U. S. on resuming searches for the remains of GIs missing from the Korean War have begun, according to an announcement by the Communist state.

"Work for talks between the militaries of the PDRK (North Korea) and the U. S. is now underway," said a spokesman for North Korea's Foreign Ministry.

The Pentagon said earlier in the month that it had initially contacted Pyongyang about resuming the searches, which were halted in May, 2005 over concerns about North Korea's nuclear program. Pyongyang's announcement came hours after the U.S. offered \$900,000 to North Korea for flood assistance.

It also follows a series of meeting between Pyongyang, Seoul, Washington and Beijing to halt North Korea's nuclear program.

The announcement was good news for VFW members, whose delegates approved *Res 423—Renew POW/MIA Discussions with North Korea*—at the organization's 112<sup>th</sup> National Convention in August.

A total of 7,986 Korean War GIs are still listed as missing on the Korean peninsula, the vast majority of whom are in North Korea. The Pentagon's joint POW/MIA Accounting Command conducted 33 search missions in North Korea between 1996-2005. They recovered

229 "probable" remains, according to the Pentagon's POW/Missing Personnel Office, of which 88 have been identified and returned to families.

Work is progressing on the Seattle Reunion. VAUGHAN KRUGER has been very busy doing legwork for me and we will soon have information out to you about all of the events and festivities. There will be some new twists and surprises so stand by.
